# ORDINANCE PROVIDING FOR BUDGET AND APPROPRIATIONS OF THE NORTHLAKE PUBLIC LIBRARY DISTRICT, COOK COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING JULY 1, 2024 AND ENDING JUNE 30, 2025

WHEREAS, The Board of Library Trustees of the Northlake Public Library District, Cook County, Illinois, caused to be prepared in tentative form a Budget and the Secretary of this Board will make the same conveniently available for public inspection for at least thirty (30) days prior to final action thereon; and

**WHEREAS**, A public hearing was held as to such Budget on the 15<sup>th</sup> day of August, 2024, and Notice of said hearing was given at least thirty (30) days prior thereto as required by law, and all other legal requirements have been complied with.

**NOW, THEREFORE**, Be it Ordained by the Board of Library Trustees of the Northlake Public Library District, Cook County, Illinois, as follows:

Section 1: That the fiscal year of this Public Library District is hereby fixed to begin on July 1, 2024, and end on June 30, 2025.

Sections 2: That the following Budget containing an estimate of the amount available and expenditures and the appropriations contained therein be and the same is hereby adopted as the Budget and Appropriations for this Public Library District for this fiscal year; and the sum of \$4.600,170.00 or as much thereof as may be authorized by law, is hereby appropriated for the purpose of the Northlake Public Library District, as hereinafter specified for said fiscal year.

16. Unemployment Compensation Insurance

The foregoing appropriation is hereby appropriated from the proceeds of a special tax for Unemployment Compensation Insurance purposes and is in addition to all other library district taxes as provided by law.

## PART VIII ESTIMATED EXPENDITURES - PURCHASE, CONSTRUCTION AND MAINTENANCE OF SITES AND BUILDINGS

17. Purchase of Sites and Buildings, Construction, Equipment, Rental, Maintenance and Repairs of Buildings

\$115,000.00

The foregoing appropriation is hereby appropriated from the proceeds of a special tax for the purposes of; Purchase of Sites and Buildings, for the Construction and Equipment of Buildings, for the Rental of Buildings required for library purposes, and for Maintenance, Repairs and alterations of library buildings and equipment, and is in addition to all other library district taxes as provided by law.

### ESTIMATED EXPENDITURES – DEBT SERVICE FUND

18. Debt Service \$714,150.00

The foregoing appropriation is hereby appropriated from the proceeds of a special tax for the purposes of: Debt Service repayment.

## PART X ESTIMATED EXPENDITURES - WORKING CASH FUND WORKING CASH FUND \$0.00

19. This Board of Library Trustees hereby identifies the above library Working Cash Fund, which now has a balance prior to receipts in the 2023-2024 fiscal year of \$204,135.22 Said amount shall not be deemed a current asset available for library purposes. The foregoing appropriation is hereby appropriated from the proceeds of a special tax for Working Cash Fund purposes and is in addition to all other library district taxes as provided by law.

Section 3: That all unexpended balances of any item or items of any general appropriation in this Ordinance be expended in making up any insufficiency in any other item or items in the same general appropriation and for the same general purpose of any like appropriation made by this Ordinance.

**Section 4**: That the invalidity of any item or section of this Ordinance shall not affect the validity of the whole or part thereof.

<u>Section 5</u>: That all ordinances or parts of ordinances conflicting with any provision of this Ordinance be and the same are hereby repealed.

Section 6: That the Board of Library Trustees of the Northlake Public Library District has established a Special Reserve Fund to be accumulated from the unexpended balance from the proceeds received from the library taxes levied for the year 1975 and subsequent years, said fund to be accumulated and set aside as a Special Reserve Fund for the purchase of sites and construction and equipment of buildings for library purposes in accordance with Chapter 16 / 40-50 of the Illinois Compiled Statutes, and that said Board of Library Trustees shall adopt a plan or plans pursuant to the provisions of Article 5 of the Public Library District Act.

<u>Section 7</u>: That this Ordinance shall be in full force and effect from and after passage, approval and publication as proved by law.
