ORDINANCE NO. 24-607 ORDINANCE LEVYING AND ASSESSING TAXES OF THE NORTHLAKE PUBLIC LIBRARY DISTRICT, COOK COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING JULY 1, 2023 AND ENDING JUNE 30, 2024

BE IT ORDAINED by the Board of Library Trustees of the Northlake Public Library District as follows:

Section 1: That the sum of THREE MILLION TWO HUNDRED FORTY FIVE THOUSAND TWO HUNDRED AND EIGHTY NINE DOLLARS (\$3,245,289.00) be and the same is assessed and levied from and against all taxable property within the limits of the said Northlake Public Library District as the same is assessed and equalized for State and County purposes for the current year, 2024, and are to be applied in liquidation of the appropriations heretofore made by Ordinance adopted by the Board of Library Trustees of the Northlake Public Library District at a meeting thereof regularly convened and held on October 17, 2024, and duly published as provided by law; the various objects and purposes for which said appropriations were made are set forth under the column entitled "Amount Appropriated" and the specific amount hereby levied for each object and purpose is set forth under the column entitled "Amount To Be Raised By Tax Levy," as follows:
